#### **Approval of Agenda:**

#### **President's Remarks:**

- Meeting starting late to due city error in scheduling our meeting room. Had to be relocated.
- Not much has happened since the end of the season
- Was invited to attend BMLA banquet.
- Recognized accomplishments of minor players, many of whom will be play junior and major for us in the future.

#### **Team Reports:**

#### Major:

- Missed the playoffs by one game.
- Missing a few key players for the last couple of games, likely would have made a difference.
- Bigger and better things to come. The team has huge potential for growth and improvement.
- Leadership core was strong.
- Staff will be meeting in the next couple of weeks to start planning for next season.
- Some of our young players got good exposure.



- Next year we should have back players who went out West or to Sr. B.
- The team was competitive, with the exception of a couple of games, most were kept very close including two which were lost with under 2 seconds to play.
- There was a steep learning curve for the staff taking on new responsibilities.
- We are planning an affiliation with Orangeville Jr. A for next season. Cannot be finalized until after the draft.
- We are currently the only MSL team with no Sr. B affiliate. Looking into options for next year.

#### Jr. A:

- AGM is coming up shortly.
- Will be deciding if Nepean joins the league or not, the travel cost involved is still contentious.
- Draft will be held in January, we currently have two picks.
- Four players graduated, 16 returning.
- Will be meeting with staff in the next two weeks to discuss plans for next year.

#### Jr. B:

- Missed playoffs.
- Brock will be stepping down as Head Coach to focus on coaching minor.
- Justin Huggins will be the new Head Coach, Brent will approve his bench staff.
- Barrie is applying for a new team.
- Cost of travel is a huge issue for the league.
- Need to start working on sponsorship ASAP.
- Brock notes that he is not stepping down to focus on Minor, but because he feels he was not given the tools to succeed with the team.
- Changes need to be made at the top of the team.
- Discussion on the viability of the team and recruitment of players follows.
- Jr. B has a league wide issues with number of players. Many teams struggling to fill rosters.

#### Field:

- Season started last weekend.
- A few U17 players have joined to round out the roster, as well as some players from other centres.
- 2-0 start to the seasons leaves us alone in first place.
- The U17 players have a lower registration fee due to the workings of the leagues.

#### **Treasurer's Report:**



- Matt distributed account reports to the Board earlier (included in Appendices A and B).
- End of September is the year end for the BELC.
- Still waiting on the money form the 2022 Minto. Keith will contact Fionna to follow up.

- Concerned about the return on investment.
- Start up cost discussed at last meeting will also have a \$750/month fee on top.
- May be better suited for the BMLA, suggested Chris look into it.

#### **Committees:**

#### **Fundraising:**

- Matt has asked John Sanderson if he will chair the committee, has not heard back.
- In the interest of getting the committee started, Matt will stand as interim chair until someone to take the position permanently can be found.

#### Motion to elect Matt as interim Chair of the Fundraising Committee.

- Wes volunteers to sit on the committee, would also like to see the formation of a Promotional Committee in the near future.
- Bingo currently lists Jr. A Excelsiors as a partner on their website, should be run through the BMLA with volunteers from BELC helping out to comply with under-18 regulations.

#### **AGM**

- Constitution requires AGM to be held on the 3<sup>rd</sup> or 4<sup>th</sup> Monday of October unless there are extenuating circumstances. These dates are the 16<sup>th</sup> or 23<sup>rd</sup>.
- Glenn will be gone both of those dates.
- Board agrees the AGM should not be held without the President in attendance.

#### Motion to recognize extenuating circumstances in accordance with C 3:03, d.

- AGM will be held on the 5<sup>th</sup> Monday instead (Oct. 30). Matt will book the room and send notice to the membership.

#### **Banquet and Awards:**



- Concerns of getting players to a banquet have not been solved.
- Does not seem feasible to gather everyone at once.
- May be best to hold a "senior's day" to bring back players receiving awards.
- Can be filmed and posted on social media.
- Executive Committee still has to present 2022 Mush Thompson and Bruce Wanless awards.

#### **New Business:**

- Ron suggests each team hires a gameday manager for next year.
- We need more events at games. Best attended Majors games were Indigenous Heritage Day, and BGCP fundraiser. Events bring more people.
- Beer was not sold due to the cost of the licences, however could be used as an incentive as opposed to a money maker.
- Matt notes a go-between would make his job easier as GM are often busy right before games, making organizing ceremonies and events difficult.
- Sheridan and/or Algoma may have interns available in sports and event management.
- Brent notes that Life Member Chuck Williams recently passed away.
- Social media post was put out. Will make sure to recognize at the AGM and first game next season.
